- Applications will be accepted online only through the prescribed portal.
- Nomination Fee: ₹400 (Non-Refundable)- Applications will be valid only after successful payment.
- Submission of the nomination form does not create any right, guarantee, or legal claim for selection.

### 3. Rules & Regulations

(a) General Provisions- This is not a government election.- It is an internal organizational process of RASWA.- All appointments will be made by the RASWA Election / Governance Committee through consensus.

(b) Selection Process- Members will be appointed only by the decision of the RASWA Election Committee.- Online polls/surveys may be conducted for feedback, but these are not legal elections.

(c) Tenure of Positions- Tenure: 1 year- Active and dedicated members may be promoted the following year.

(d) Nomination Rules- Nomination fee is non-refundable & non-transferable.- False/misleading/incomplete applications will be rejected.- Members cannot reapply for the same post held in the previous year.

(e) Discipline & Suspension- Any member found guilty of misconduct, false information, or anti-RASWA activity shall be suspended.- All members must adhere to the objectives and policies of RASWA.

(f) Legal Disclaimer- This process is an internal appointment procedure only.- It has no connection with ECI, university elections, or any government authority.- No legal right/claim shall arise from participation.- Any disputes will be settled internally within RASWA only.

(g) Complaints- For mistakes, complaints, or concerns against any Election/Nomination Coordinator or Chief Election Officer, contact the Governance Body through the official website and email.

Important Note:By submitting a nomination form, applicants will be deemed to have accepted all Rules & Regulations stated above.
